

**Stafford County Commissioners  
Minutes of Meeting  
October 27th, 2021**

The Stafford County Board of County Commissioners met in regular session on Wednesday, October 27<sup>th</sup>, 2021, in the Commission Room in the Annex. Chairman Grimmatt called the meeting to order at 8:30 a.m. Present: Clayton Grimmatt, and Todd Wycoff.

Sheriff Rob Murrow presented a quote from Custom Signals for five radar units for the sheriff vehicles. Commissioner Wycoff moved and Grimmatt seconded to allow the purchase of five radar units at a cost of \$ 12,710.00. Motion carried 2-0. The cost will be taken out of the Sheriff Reserve Equipment Fund.
